DIRECTIONS BY AIR/LAND TO MARRIOTT HOTEL

The Wentworth is located less than an hour north of Boston's Logan Airport, and 45 minutes from Portland (Maine) Jetport and Manchester (New Hampshire) Airport.

FROM THE SOUTH AND WEST (BOSTON AND MANCHESTER):

North on I-95 in New Hampshire, take Exit 3 and make a right onto Route 33 East. Drive approximately one mile and make a right at the traffic light onto Peverly Hill Road. Go straight (across Route 1) and the street name changes to Elwyn Road. Continue straight on Elwyn Road and make a left onto Route 1A North (Sagamore Road). Make a right onto Route 1B (Wentworth Road) Proceed past the Wentworth-by-the-Sea Golf Course, across the New Castle Bridge to the hotel entrance.

FROM THE NORTH (LAKES AND MOUNTAIN REGION & MAINE):

South on I-95 to Exit 3B. You are now on Route 33. Then follow directions from the South (above).
