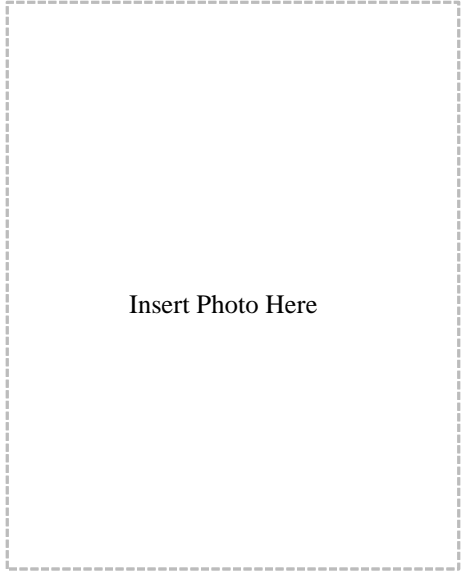

### AOC Election Campaign Rules and Guidelines

1. Distribution of a standard election guide to each member provides sufficient information for each member to select the candidates of his or her choice. Campaigning and electioneering are prohibited.
2. Labels for full or partial membership will not be provided to candidates for use in direct mail campaigning.
3. Candidates should not use direct mail to the membership for campaign purposes or provide such material to chapters for direct mailing to the members. Each year the N&E Committee or AOC staff will remind Chapter Presidents of this policy.
4. In the past, Chapter officers and in some cases the editor of a newsletter without review by the Chapter's Board has endorsed a full slate of candidates. This endorsement was mailed to each member of the chapter. Endorsements should be sent only with the approval of a two-thirds vote of all officers and directors in the Chapter. The endorsements should be limited to Regional Directors within the region and for a Regular Director who is a member of the Chapter. Chapters should not mail campaign material of candidates for the office of President to their members.
